VI. President's Report (Ed)

Ed Klonoski reported that with the new Governor there will be challenges for the college. The state is \$3.3 billion in debt. The Governor will most likely have his budget proposal in early February, there will be givebacks, and cuts to higher ed. He indicated that we are preparing for a possible 15% cut for higher ed.

For matriculation, the colleges goal is to get 5,000 students in 5 years. This year our goal is to reach 3,200 students, so far we are on target. The August matriculation was 10% higher than in June. The distance learning course enrollment total is up 25%, 1,968 matriculated students – more students, more revenue.

Masters degree update – program is being reviewed by the Board of Higher Education, then it will go to NEASC.

Charter Oak is looking at a new academic program – connecting to the workforce, workforce impact. A survey went out and the question was asked what marketplace do you want to see from us?

The foundation letter that was recently sent out prompted discussion. It was an excellent letter. Ed indicated that kudos should go to Marlene Woodman as she worked very hard on making that happen.

Still looking at May 10 as the Foundation/Alumni meeting

VII. Other Business

There was no other business before the Board.
